As a member of the public and nearby resident, I submit the following comments regarding a zoning change request for the lands located at 407-419 Mapleview Dr W in Barrie.

My wife and I have . Since moving

to the area, we have experienced considerable disturbance on a daily basis related to road traffic.

Prior to the pandemic, the traffic in the area was far denser, moving at a rate of typically >70 km/hr. The writer has been present at some significant MVAs in the area. At two of the accidents, vehicles were

left with the driver's side on the ground. I recall one of the accidents in early July 2017, occurring just several

households east of the proposed area. The vehicle was struck while turning into the (southside) driveway.

The vehicle came to a stop in the middle of the front lawn. Traffic was heavy late in the afternoon.

The pandemic has resulted in some behaviour changes impacting traffic related to this project area. Recent

media reports indicate there is a population shift from the GTA to surrounding communities. Our Mayor has noted

the same in recent interviews. Traffic was cited as a frequent concern at the initial public meeting by nearby

residents who experience it. Mapleview Dr W has become a dragstrip-like area due to its configuration. Noise and speed

of vehicles are often the top concern of Barrie residents. Vehicle racing has escalated in many communities.

Mapleview Dr W is a 24/7 conduit for transport trucks supplying numerous stops along their routes. M-F, school buses,

pick-up and drop-off children at daycare facilities at an adjacent church. The road is a popular route for travelers visiting

cottage country and accessing seasonal recreation facilities. An additional project on a grander scale is also

proposed for lands to the east bordered by Essa Road & Mapleview Dr W. Traffic volume will no doubt increase

as vehicles access that area.

The writer supports the concept in terms of providing additional housing. The writer disagrees with the related traffic study

and feels that a centre turning lane or reduced speed limits be considered. Of course, these fall within the responsibility of the City.
