RECOMMENDED MOTION

1. That the Mayor and City Clerk be authorized to execute the Transfer Payment Agreement (TPA) with the Province of Ontario as represented by the Ministry of Transportation related to the public transit stream of the Investing in Canada Infrastructure Program (ICIP).

PURPOSE & BACKGROUND

2. The purpose of this report is to execute the Transfer Payment Agreement (TPA) with the Province of Ontario and provide additional context and information for members of Council. The TPA agreement was received on March 1st, 2021.
3. On Tuesday April 2nd, 2019, the governments of Canada and Ontario released details regarding the public transit funding stream of the larger Investing in Canada Infrastructure Program (ICIP). The purpose of the public transit funding is to build new urban transit networks and service extensions that will transform the way that Canadians live, move and work. This stream funds capital costs to construct, expand, and improve public transit networks.
4. The ICIP program has replaced the previous version of transit funding known as the Public Transit Infrastructure Fund (PTIF) and is governed by the Integrated Bilateral Agreement for Investing in Canada Infrastructure Program between the Government of Canada and the Government of Ontario that was signed on March 26, 2018 (the "Bilateral Agreement").
5. The City of Barrie has been allocated funding from the provincial government in the amount of \$19,513,005 and federal government in the amount of \$23,417,948 and with a municipal contribution of \$15,613,917 to invest towards total capital project costs of \$58,544,870. All capital projects are to be substantially complete by October 31, 2027.
6. As funding was allocated to municipalities based on ridership (using 2015 data), it is important to note that continuing to grow ridership will increase the City of Barrie's opportunity to leverage a greater amount of future funding allocations from upper-level governments. Details of the funding from the various levels of government is listed in **Table 1**.

ANALYSIS

- Staff have recently received the ICIP Transfer Payment Agreement and require a supporting by-law for the agreement to be executed.
- The ICIP Program capital project funding requests are coordinated with funding intakes. The first intake closed on May 28th, 2019. Barrie submitted, and subsequently received approval, for five transit capital projects summarized in **Table 2**. The timelines of future intakes, and additional transit project funding requests, are unknown at this time.

FINANCIAL

11. The parameters associated with the ICIP funding indicate that all funds are to be substantially completed and expensed by October 31, 2027. A summary of the ICIP funding allocations by project is provided in **Table 3** below.

12. Please note for the Allandale Mobility Hub and Downtown Connection Hub Projects, the budget may be refined further as staff work through the IPD validation period with the successful proponent. If there is any further variation in the budget or funding implications, staff will assess and report back to council, if required.
