BY-LAW NUMBER 2021-

A By-law of The Corporation of the City of Barrie to permanently close the highway described as Part of original road allowance between Lots 5 and 6, Concession 13, designated as Part 1 on Plan 51R-32592, (known as Veterans Lane), and being Part of PIN 58733-0392(LT).

WHEREAS Section 8 of the *Municipal Act, 2001, S.O. 2001,* c. 25 (the "Act"), provides that a municipality has the capacity, rights, powers and privileges of a natural person for the purpose of exercising its authority under the Act;

AND WHEREAS pursuant to section 34 of the Act, the council of every municipality may pass bylaws to permanently close highways under the jurisdiction of the Municipality;

AND WHEREAS the Council of The Corporation of the City of Barrie adopted Motion 20-G-010;

AND WHEREAS Part of original road allowance between Lots 5 and 6, Concession 13, designated as Part 1 on Plan 51R-32592, and being Part of PIN 58733-0392(LT), is no longer required for highway purposes.

NOW THEREFORE the Council of The Corporation of the City of Barrie enacts the following:

- 1. **THAT** Part of original road allowance between Lots 5 and 6, Concession 13, designated as Part 1 on Plan 51R-32592, and being Part of PIN 58733-0392(LT) be and hereby is permanently closed.
- 2. **THAT** the City Clerk be authorized to execute all documents necessary to carry out the intent of this by-law.
- 3. **THAT** this by-law will have effect upon registration in the Land Registry Office of Simcoe County.
- 4. **THAT** Schedule "A" to this by-law, being an Affidavit of Samantha Hofing, sworn April 8, 2021 forms a part of this by-law.

READ a third time and finally passed this 12th day of April, 2021.
