**BY-LAW NUMBER 2021-**

**A By-law of The Corporation of the City of Barrie to amend By-law 89-86 being a by-law to designate private roadways as Emergency Fire Routes along which no parking of vehicles shall be permitted.**

**WHEREAS**, pursuant to the *Fire and Protection Act, 1997*, S.O. 1997, C.4, s.7.1.(1)(c) the Council of any municipality may designate private roadways as emergency fire routes along which no parking of vehicles shall be permitted;

**AND WHEREAS**, the Council of The Corporation of the City of Barrie adopted By-law 89-86 being a by-law to designate private roadways as emergency fire routes along which no parking of vehicles shall be permitted;

**AND WHEREAS**, by motion 05-G-514, it is deemed expedient that the Council of The Corporation of the City of Barrie amend By-law 89-86, as amended, being a by-law to designate private roadways as emergency fire routes along which no parking of vehicles shall be permitted.

**AND WHEREAS** Section 8 of the *Municipal Act, 2001*, provides that the power of a municipality shall be interpreted broadly so as to confer broad authority on the municipality to enable the municipality to govern its affairs as they consider appropriate and to enhance the municipality's ability to respond to municipal issues.

**NOW THEREFORE** the Council of The Corporation of the City of Barrie enacts as follows:

1. **THAT** By-law 89-86 be amended by adding Schedule 270 attached hereto as Schedule "A" designating an emergency fire route at 430 Ferndale Drive South (430 Ferndale Dr S LP).
2. **THAT** By-law 89-86 be amended by adding Schedule 271 attached hereto as Schedule "B" designating an emergency fire route at 300 Essa Road (300-306) (SSCC 438 'The Gallery').
3. **THAT** By-law 89-86 be amended by adding Schedule 272 attached hereto as Schedule "C" designating an emergency fire route at 357 Yonge Street (Allandale Station Retirement Residence).
4. **THAT** this By-law shall come into force and effect immediately upon the final passing thereof.

**READ** a first and second time this 14th day of June, 2021.

**READ** a third time and finally passed this 14th day of June, 2021.

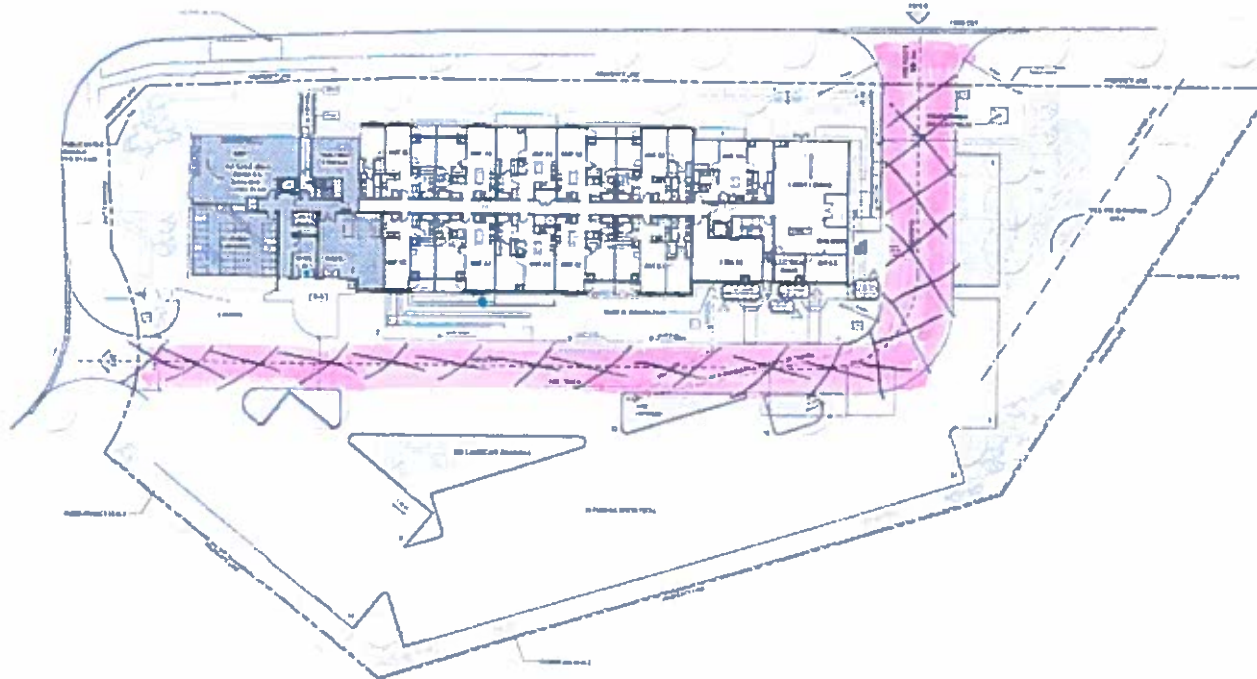

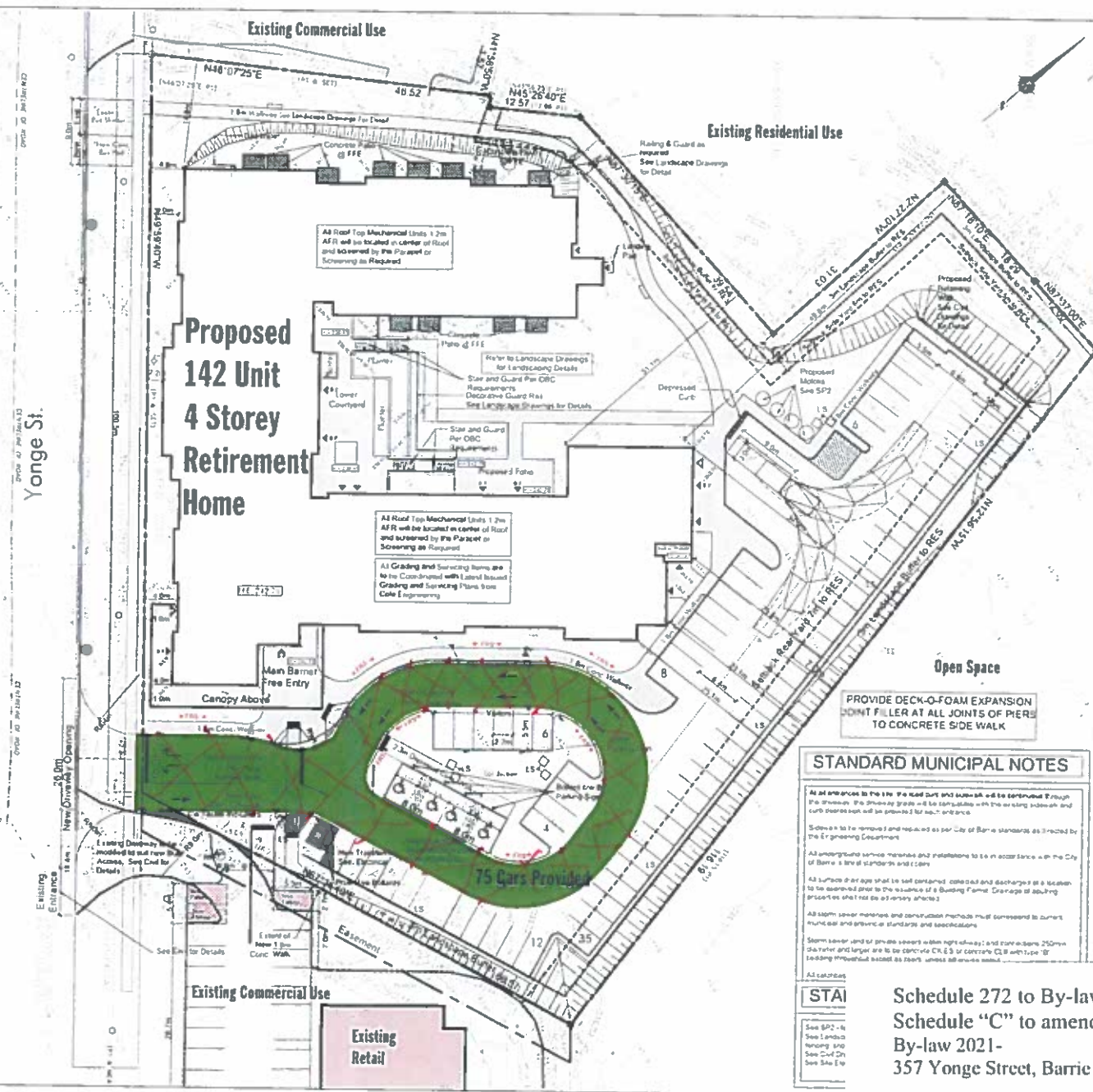
