### 20-G-025 DEVELOPMENT CHARGE INTEREST - BILL 108

- 1. That the City authorize the following for the new mandatory deferral and instalment payments for non-profit housing developments in accordance with Section 26.1 (7) of the *Development Charges Act*:
  - a) Interest charges be waived during the first five years of the loan;
     and
  - b) Beginning on the date that the sixth instalment is due, interest charges be applied to development charges outstanding at a rate established by the City's Weighted Average Cost of Capital, as determined by the Director of Finance and be fixed for five year increments for the remaining duration of the loan.
- 2. That the City authorize the following for the new mandatory deferral and instalment payments for rental housing that is not non-profit housing and for institutional developments in accordance with Section 26.1 (7) of the *Development Charges Act*:
  - a) Interest charges be applied to development charges outstanding, at a rate fixed for the duration of the loan and established by the City's Weighted Average Cost of Capital on the date that the first instalment is due and as determined by the Director of Finance.
- 3. That the City authorize an interest charge based on the City's Weighted Average Cost of Capital as determined by the Director of Finance for the new "frozen" development charges fixed from the date of the Site Plan or Rezoning application as the case may be and to the date of payment in accordance with Section 26.2 (3) of the Development Charges Act. (FIN002-20) (File: F00)

### 20-G-026 RODNEY STREET PARKING INVESTIGATION (WARD 1)

That Traffic By-law 80-138, Schedule 'A', "No Parking Any Time" be amended by adding the following:

### 20-G-032 PURCHASE OF SOAPBOX ART PIECE

- 1. That the Mayor and City Clerk be authorized to execute an agreement with artist team Chris Hanson and Hendrika Sonnenberg for the purchase of *Soapbox* that has been leased by the City since the Fall of 2017 and installed in the City Hall courtyard.
- That staff in the Economic and Creative Development and Corporate Facilities Departments be authorized to decide upon placement of permanent interpretive signage about the art piece in the vicinity of the sculpture.
- 3. That the draft agreement attached as Appendix "A" to Staff Report EDC002-20, be executed with any other terms and conditions deemed necessary by the Director of Economic and Creative Development and in a form acceptable to the Director of Legal Services. (ECD002-20) (File: R07)

#### **SECTION "D"**

### 20-G-033 BRIX MAKERSPACE AND WOODSHOP - ALLOCATION OF WOODSHOP FUNDING

- That the City of Barrie's previously allocated contribution for a community woodshop be allocated to the BRIX (Barrie Region Innovation Exchange), a not-for-profit organization formerly known as the Barrie Community Woodshop to secure a base programming space, be approved with the following conditions:
  - a) The contribution be limited to two years, and that staff in the Economic and Creative Development Department report back to City Building Committee in the second quarter of year two to evaluate operational success;
  - b) The previous total annual subsidy of \$27,500 (\$17,585 subsidy plus internal costs for utilities, etc.) be adjusted to \$35,000 in 2020, and \$20,000 in 2021 in recognition of essential startup costs to be funded within existing departmental budget; and
  - c) The recipient consent to meeting specified milestones and collecting pre-determined success metrics with City staff, and that an Agreement be signed by BRIX outlining these terms.
- 2. That a one-time grant of up to \$300,000 to be funded from the Community Benefit Reserve (GL 35040) be allocated to BRIX to facilitate the construction of a complete woodshop within the leased space, after the following conditions, to the satisfaction of the Director of Economic and Creative Development, and Director of Finance are met:
  - The demonstration of matching funding from grants, fundraising, or private sector contributions at a minimum two (City funds): to one ratio;
  - b) Demonstration of a commitment to a minimum of a ten year lease and associated build out plan for a complete wood-shop operation; and
  - c) The BIRX work with a commercial realtor to negotiate the terms of the lease.
- 3. That as a result of the grant funding, no further subsidy will be provided between the years 2022 to 2032 and any subsidy past 2032 would be subject to Council approval. (ECD003-20)
