 - 10:30 p.m. to 11:30 p.m. Monday - Thursday
 - 10:30 p.m. to 1:45 a.m. Friday and Saturday
 - b) The hours that a person be permitted to remain in the outdoor area be extended from:
 - 11:15 p.m. to 12:15 a.m. Monday - Thursday
 - 11:15 p.m. to 2:30 a.m. Friday and Saturday
2. That all other regulations and by-laws, including no amplified sound on the patios after 11:00 p.m. continue to apply with the operation of the patios.
3. That non-compliance of municipal regulations and by-laws could result in permits being revoked or further conditions being added to the permits.
