The Active Transportation and Sustainability Committee met and reports as follow(s):

**TMP-28620**      **WAYFINDING STRATEGY**

Robb MacDonald, Tourism Development Coordinator provided a presentation on the Wayfinding Strategy.

Mr. MacDonald discussed slides concerning the following topics:

- A project overview consisting of three phases to align with Council's Strategic Priorities: development of the Wayfinding Strategy, signage design and installation;
- Project Goals and Objectives, which provide direction and assist with navigation from both within and outside of the City to areas, such as the waterfront, downtown, parking, shopping, and dining; and
- Phase one and project deliverables, such as the Audit and Assessment Report, the Recommendations Report, and the Strategy Development Report.

Members of the Committee provided suggestions, such as highlighting destinations, Active Transportation routes and travel times. The Committee asked questions of Mr. MacDonald and received responses.

**TMP-28621**      **BIKE THE NIGHT**

**TMP-28634**      **CIRCULAR ECONOMY/WASTE COLLECTION CALENDAR**

The Committee and Sandra Burnet, Associate Director of Business Performance and Environmental Sustainability discussed the Circular Economy Waste Collection Calendar. The Committee suggested using the calendar to promote Active Transportation and Sustainability, such as the Bike the Night Event, a Bike to Work Day, Pollinator Week, and Barrie as a

Bee City. It was also suggested that a digital copy of the calendar be available online with hyperlinks to events and registration, such as the Bike the Night Event and the Cycle Barrie Public Information Centre (PIC), and the Active Transportation website.

### **TMP-28635 URBAN FOREST CONCEPT - 3-30-300 RULE**

Andee Pelan, Living Green Barrie provided a presentation on the Introduction to the 3-30-300 Rule.

Ms. Pelan discussed slides concerning the following topics:

- The importance of urban trees and how they make us healthier, save us money, and are good for climate change adaption and mitigation;
- Promoting health and wellbeing through urban forests through introducing the 3-30-300 rule;
- A new guiding rule of thumb and the need to bring trees and nature to the people to capitalize on the benefits;
- 3 trees from every home: the importance of seeing green from a window for mental health and wellbeing;
- 30 percent canopy cover in every neighbourhood: cooling shade, more time spent outside, and healthy social interaction;
- 300 metres from the nearest park or green space: as a recommendation from the World Health Organization, more green space for recreation; and
- Tree canopy coverage throughout the City of Barrie.

Members of the Committee asked questions of staff and Ms. Pelan and received responses.
